Applications in prescribed form are invited from the citizen of India for the filling up of the following posts in various Departments of Mahapurusha Srimanta Sankaradeva Viswavidyalaya (MSSV), Nagaon, Assam:

Teaching Posts

1. **Assistant Professor (Regular basis):** Assamese, Social Work and Sociology.

Qualifications as per the UGC norms.

DETAILED INFORMATION

I. Eligibility to apply for the posts:

1. The Applicant must be a citizen of India.
2. He/she must be medically fit both in mind and in body-a certificate duly signed by the District Medical Officer, Nagaon District or any competent Registered Medical Officer, approved by the Vice-Chancellor, shall have to be produced by any person who would be appointed as a Teacher, before/she is allowed to join.
3. A certificate about good character from the Head of the Institution last attended or served shall accompany an application for any post of a Teacher.
4. The candidate must possess the minimum qualifications for the post.

II. General Qualification, Experience and Requirements:

1. Assistant Professor: Minimum qualification and experience:

- (i) Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or Ph.D. Degree (under the new regulation of UGC).
- (iii) Candidates with NET and Ph.D. shall be given preference.

APPLICATION PROCEDURE

1. **Application form:** Prescribe application form may be downloaded from the University website i.e., www.mssv.co.in.
2. **Application Fees and Last Date:** Candidate are required to pay an amount of **Rs. 2,000.00 (Rupees two thousand) only for teaching post** by demand draft in favour of "REGISTRAR, MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA" payable at "State Bank

of India, Nagaon Main Branch (IFSC: SBIN000146)” or Cash at Accounts Branch of the University as an application fees for the post.

Completed application in prescribed form along with necessary enclosures must reach “REGISTRAR, MAHAPURUSHA SRIMANTA SANKARADEVA VISWAVIDYALAYA, H.B. PATH, KOLONGPAR, NAGAON – 782001” on latest by 02nd September, 2019.

N.B.:

- i. Those who are willing to apply more than one post they must submit separate form with separate application fees.
- ii. The name of post and department must be written on the envelop of the application.
- iii. Those in employment should submit their applications through proper channel up are submit the NOC from the authority concern.
- iv. Near fulfilment of qualification will not entitled an applicant for inviting to the interview.
- v. The University reserves the right to select candidates for appointment to the above mentioned posts on the basis of its immediate requirements.
- vi. Canvassing directly or indirectly shall disqualify a candidate.
- vii. No TA/DA will be provided by the University for attending the interview.

3. Conditions to be fulfilled after appointment:

- a) A person appointed to the post of a Teacher join **within one month from the date of issue of appointment order**, failing which the appointment order is liable to be cancelled, provided that in exceptional circumstances, the Vice-Chancellor may extend this period.
- b) Before a person appointed to the post of a Teacher joins in his/her post, he/she shall execute an agreement with the university that he/she shall strictly abide by the provisions of the Acts and the Ordinances. A Teacher shall also undertake in the agreement to submit to the Vice-Chancellor a self-appraisal report of his/her performance annually.
- c) The person, after joining the post of Teacher, will be subjected to the provisions of the MSSV Teachers' Service Conditions Ordinance.
