- (a) 1.3 Earth/ sand filling in plinth in layers not more than 150mm thick including necessary carriage watering, ramming etc. complete as directed and specified including payment of land compensation, Forest Royalty, sales tax and other duties and taxes as may be necessary as per rules of the Govt. of Assam.
- (i) With river sand or soil (predominantly non plastic) by truck carriage including loading and unloading
